#### **SUMMARY OF SERVICES**


CJCC provides the following services:

OBJECTIVE 1: IMPROVE MULTI-AGENCY COLLABORATION AND PLANNING AND ENCOURAGE DATA-DRIVEN DECISION-MAKING BY PROVIDING CJCC MEMBERS WITH UPDATED INFORMATION AND ANALYSIS.

- INITIATIVE 1: Provide analytical reports in support of Juvenile GunStat sessions.

  CJCC has facilitated the requisite interagency strategic planning to convene Juvenile Stat sessions going forward. Analytical reports will be provided pursuant to the agreed upon format in FY11.
- INITIATIVE 2: Provide research and data analysis in support of the Juvenile Detention Alternatives Initiative (JDAI) in the District of Columbia.

Monthly data reports are compiled and disseminated to Juvenile Detention Alternative Initiative (JDAI) stakeholders, documenting the movement of youth through the juvenile justice system. Issues are researched as they come up in order to identify best practices and responses to challenges presented. Stakeholders have utilized the data to review program usage and resource/programmatic allocations or adjustments.

OBJECTIVE 2: PROVIDE A MULTI-AGENCY STRUCTURE TO FACILITATE STRATEGIC PLANNING, TRACK PRIORITIES, EVALUATE PROGRESS, GENERATE REPORTS AND IMPLEMENT PILOT PROJECTS.

INITIATIVE 2.1: Provide a public safety forum for identifying citywide priorities.

CJCC convened the following forums:

## OBJECTIVE 3: ASSIST MEMBER AGENCIES WITH INFORMATION SHARING ACROSS THE FEDERAL AND LOCAL CRIMINAL JUSTICE SYSTEM.

INITIATIVE 3.1: Develop new architecture in Justice Integrated Information System (JUSTIS) to support user requests and needs.

The Enhancement/Modification of the JUSTIS architecture (Hardware, Application/ software) to support user requests and needs is an ongoing process. This year the focus was on Electronic Exchange of information between criminal justice partner agencies. This was accomplished by launching the 'Pilot' for filing a criminal case electronically.

- INITIATIVE 3.2: Training of Agency and key Stakeholders Personnel in JUSTIS.
   CJCC conducts JUSTIS "Train-the-Trainer" days whereby designated agency representatives are trained by CJCC IT Personnel.
- INITIATIVE 3: Adult GunStat Sessions.
   CJCC convened a total of 12 Adult GunStat Sessions.
