

# Office of the Deputy Mayor for Public Safety and Justice (DMPSJ) FY2016 Performance Accountability Report (PAR)

## Introduction

The Performance Accountability Report (PAR) measures each agency's performance for the fiscal year against the agency's performance plan and includes major accomplishments, updates on initiatives' progress and key performance indicators (KPIs).

### Mission

The mission of the Office of the Deputy Mayor for Public Safety and Justice is to provide direction, guidance, support and coordination to the District's public safety agencies to develop and lead interagency public safety initiatives to improve the quality of life in the District's neighborhoods.

### Summary of Services

The Office of Deputy Mayor for Public Safety and Justice was created in January 2011 to provide guidance, support, and coordination of public safety and justice agencies of the District. During FY 2013 and 2014, the role of the agency has been expanded to include oversight of service programs that previously had operated as independent agencies. This structure enhances the oversight function and improves service delivery.

# **Overview** – Agency Performance

The following section provides a summary of DMPSJ performance in FY 2016 by listing DMPSJ's top accomplishments, and a summary of its progress achieving its initiatives and progress on key performance indicators.

### **Top Agency Accomplishments**

In FY 2016, DMPSJ had 5 Key Performance Indicators. Of those, 0 were neutral, and another 5 were not able to be reported by the end of the fiscal year. Of the remaining measures, 0% (0 KPIs) were met, 0% (0 KPIs) were nearly met, and 0% (0 KPIs) were unmet. In FY 2016, DMPSJ had 3 Initiatives. Of those, 100% (3) were completed and 0% (0) were nearly completed, and 0% (0) were not completed.
