FY2018 Performance Accountability Report

The Performance Accountability Report (PAR) measures each agency's performance for the fiscal year against the agency's performance plan and includes major accomplishments, updates on initiatives, and key performance indicators (KPIs).

Mission

The mission of the Public Service Commission is to ensure that financially healthy electric, natural gas, and telecommunications companies provide safe, reliable, and quality services at reasonable rates for District of Columbia residential, business, and government customers.

Summary of Services

The Public Service Commission regulates public utilities operating in the District of Columbia. It does so by issuing orders in formal proceedings that may include written comments or testimony, hearings, studies, and investigations; ensuring fair and appropriate utility prices; fostering competition by licensing utility service providers and supervising the competitive bidding process; ensuring utility providers meet various environmental regulations and standards by operating in ways that conserve natural resources and preserve environmental quality; and resolving disputes among consumers and utility service providers. In addition to its regulatory services, the Commission also conducts outreach via its website, public forums, and various literatures in order to educate utility consumers and inform the public.

FC 1151 was an investigation into the impact of the Tax Act of 2018.	As a result of the Commission's actions DC Pepco ratepayers enjoyed a one-time credit of \$24.2 million and a revenue requirement reduction of \$39.4 million. WGL ratepayers will receive a \$5.1 million one time credit and a revenue requirement reduction of \$8.2 million.	Significant person hours were spent on this case.
We began Phase Two of our initiative Modernizing the Energy Delivery System for increased Sustainability (MEDSIS) by establishing 6 stakeholder Working Groups that will help chart the road map for the District's grid modernization efforts. The Commission approved the merger of AltaGas Ltd, and Washington Gas Light Company following a Settlement Agreement between the applicants, the Office of the People's Counsel, The Apartment and Office Building Association of Metropolitan Washington, the U.S. Department of Defense and others.	Among the benefits the Commission identified in approving the merger were a onetime rate credit for WGL residential customers of over \$20 million and for WGL non-residential customers of over \$5 million, \$4.2 million in energy-efficiency funding, \$1.5 million in funding for the Washington Area Fuel Fund, and development of 10 Mega Watts of energy storage or renewable resources in D.C.	Significant staff resources were expended in evaluating and approving the Application for merger.
